

Guide lines for Indirect Imports (GRN) from TIEP scheme.

(w. e. f. 07.12.2009)

1. Duly filled two (02) GRN applications should be submitted with one (01) Invoice. (Tax or Suspended)
2. Invoice should be raised in foreign currency.
3. Authorized Signature of BOI and TIEP and Company, with rubber stamp on GRN.
4. A GRN should be submitted for each seller for the total transaction effected during the relevant month by the BOI enterprise.
5. GRN' s should be submitted on a monthly basis.
6. GRN' s should be submitted on or before 5th of the following month.
7. The following CPC Codes should be used for GRN' s.
 - 1) In zone project - 5257-L21
 - 2) Out zone project - 5457-L21
8. Service charge of Rs. 250/= inclusive of Vat per GRN is payable vat the time of submission.
9. Ensure the validity of the TIEP registration before submission of a GRN.
10. Cancellation should be done on prior on prior approval of Bonding Division at Sri Lanka Customs.
11. GRN' s should be registered in the Ascidia system under following office codes by the respective service centers. (BBOI, KTBOI, BIBOI, KGBOI, PKBOI) - BOI purpose only
