## REGISTRATION OF CONTRACTORS

### Registration of Contractors for felling and removal of trees And Transport of timber from State Timber Corporation workstations - 2011.

Annually sections of State forest land are allocated to State Timber Corporation (STC) for harvesting of timber. In addition, the STC is assigned the responsibility of felling and removal of trees in State Lands selected for development works.

1. Contractors will be registered for felling trees and transporting the timber to STC Depots; and purchasing of timber selected by STC for wayside sale.

The applicants for Registration should be Sri Lankan citizens and possess immovable property worth not less than Rs.500, 000.00 and transport facilities such as working condition Lorries and tractors for transport of timber. The applicants must submit proof of above assets.

2. Contractors will be registered under D Grade for felling and transport of trees to STC Depots including those allocated by Divisional Secretaries, State Institutions and Government Departments to STC and felling and removal of trees found to be a danger to life and property and transporting them to STC Depots; and purchasing of timber selected by STC for wayside sale. The applicants need not submit a worth certificate, but must establish their identity.

Applications for registration will not be accepted from employees of Government or semi-Government Institutions, and proprietors of timber or timber based enterprises.

Contractors of Special, **A, B, C & D** Grades already registered with STC should apply for renewal of their registration for 2011. Renewal of Registration of Special, A, B & C Grades Contractors for 2011 will be done in Head Office only.

Renewal of Registration of **D** grade Contractors can be done in any Regional Office. Application Forms have already been posted to those already Registered with STC.

The STC will not take responsibility or liability for allocating work to registered Contractors.
