**(Spot Tender at Fixed price) FOR LAKVIJAYA POWER PLANT**

The Chairman, Special Standing Cabinet Appointed Procurement Committee (hereinafter referred to as “SSCAPC”) of Ministry of Power invites bids for the supply of coal for the 900MW Lakvijaya Coal Power Plant (the Plant) from registered coal suppliers and any other prospective coal suppliers (Local or international) who wish to submit a Bid. This invitation is extended by the Lanka Coal Company (Private) Limited (hereinafter referred to as “LCC”) on behalf of SSCAPC

1. Procurement method will be international competitive bidding (ICB).
2. Contract period is from October 2022 to December 2022
3. Estimated quantity of coal to be supplied to Lakvijaya plant is 300,000±10% MT.
4. Fixed CFR Price should be quoted in USD or LKR with a minimum of 180 days credit period.
5. Amount of Bid Security is USD 900,000 or LKR 330 million and shall be valid up to four weeks from the closing of the tender.
6. Deadline of bid submission is 10.00am (Sri Lanka Standard Time) on **20 October 2022**.
7. Minimum eligibility criteria for prospective bidders are, company should be registered more than 3 years, minimum of 1 million MT of coal should be supplied within last 3 years having Gross Calorific Value of above 5900 kCal, annual average turnover USD 50 million per year for last 3 financial years, and other criteria should be as per the bidding document.
8. A complete set of Bidding Document can be obtained USD 700.00 or LKR. 250,000.00 as nonrefundable charges by interested applicants on submission of a written request with **cash deposited receipt** or **Telegraphic Transfer (TT) receipt** to LCC between 09.00 AM to 04.00 PM (Sri Lanka Standard Time) from **29<sup>th</sup> September 2022 to 19<sup>th</sup> October 2022**, during working days from, **Lanka Coal Company (Private) Limited, 51/3, Suranimala Place, Off-Dutugemunu Street, Kohuwala/Dehiwala, Sri Lanka 10350.**
